The Access Centre provides clinical, social, health promotion and preventive services, as well as, access to traditional Ojibway healers.

The Gizhewaadiziwin Health Access Centre, located in the heart of the Southern Region of Treaty #3 territory, is the result of a unique partnership between area First Nations, the United Native Friendship Centre and the Sunset Country Métis.

Summary of Position:

Reporting to the Clinic Programs Manager, the Registered Nurse/Clinic Lead will provide direct nursing care, deliver health education programs and assist physician and nurse practitioners with medical procedures, to act as Lead in the daily nursing operations provided in the clinic, and participates in planning, developing, implementing, interpreting, and monitoring program operations, policies, and procedures.

Qualifications:

- Completion of a university, college or other approved registered nursing program;
- Current Ontario RN Licence and member in good standing with CNO;
- Valid Driver's Licence;
- Current BCLS certificate;
- Phlebotomy certification required;
- 2-3 years clinic/hospital recent nursing required;
- Excellent written and verbal communication skills;
- Ability to work as a team member;
- Knowledge of nursing techniques and procedures;
- Ability to provide patient care; and to prepare and maintain records;
- Ability to effectively communicate;
- As per policy, applicants should note that COVID-19 vaccination, Criminal Record Check and Drivers' Abstract are a condition of employment within Gizhewaadiziwin Health Access Centre.

Desired:

- Experience and understanding of local Indigenous communities and culture within the Rainy River District an asset.
- Ability to speak Ojibway is an asset.
- First Nations, Inuit or Métis candidates are encouraged to apply. Please self-identify.
- Current CPR certification – willing to recertify.
